how members can take action through fundraising, advocacy, and education, and how members' dollars will continue to make an impact in the lives of the most vulnerable children.

Cubelo's role is to serve as a grassroots and national spokesperson for children and bring together networks of faith-based communities, schools, universities, volunteers, advocates, elected leaders and others to unite on behalf of children. Leveraging U.S. Fund for UNICEF'S education, advocacy, and fundraising initiatives, she works to create transformational change in the lives of children around the world, empowering people to act locally. Tori's advocacy for children rights has led her everywhere from conducting briefings at the United Nations to creating a child trafficking podcast entitled "The Ending Human Trafficking Locally and Globally Podcast." She also sits on the Coalition for Global Citizenship and the Coalition to Stop Trafficking in Person. In 2016, Tori completed her Master's in Public Health at CUNY School for Public Health, focusing her studies on urban and community health. She holds a Bachelor of Arts degree in Political Science and Italian from The College of the Holy Cross.

The Nominations Committee, under the direction of chair Roxanne Adinolfi, developed a slate of officers. The proposed slate is posted on pages 4 and 5 for your review.

At the January 14, 2017 AZS meeting held in Hamilton, NJ, the proposed Bylaws and Standing Rules provisions, posted on pages 11 through 17, were presented. Executive Board members and chapter presidents voted to forward these proposals to the membership for consideration, discussion and action at the annual business meeting.

She was 2013-15 State Recording Secretary and 2011-13 State Corresponding Secretary. Schwartz served as tri-chair for the AZS convention from 2008-2011 and as 2004-06 Gamma Chapter President.

Schwartz retired after 37 years as an elementary school teacher in Trenton Public Schools. She played an active role in the Trenton Education Association. She held TEA positions of Vice President/Membership Chair, Recording Secretary, Public Relations Chair, Newsletter Editor and Chief School Delegate.

Schwartz states her desire to serve, "For the past 6 years, I have served on the Executive Committee as Corresponding Secretary, Recording Secretary and First Vice-President of AZS NJ. These positions have been professionally, as well as personally, fulfilling. I would like to continue to contribute to AZS as President. My experiences with the Trenton Board of Education, community outreach programs and my involvement with Alpha Zeta State have given me the background, knowledge and sensitivity to serve in the position of State President. Additionally, my attendance at both DKG Regional Conferences and DKG International Conventions has provided me with a deeper knowledge and understanding of the Delta Kappa Gamma Society International. As Alpha Zeta State's President, I will have the opportunity to continue to contribute and work with the other officers as well as our members. By working together, we will move our state organization forward."



The nominee for the position of AZS First Vice President is Ingrid Williams (Nu). Williams currently serves as AZS Corresponding Secretary. She served from 2009-15 as AZS Finance Committee Chair. Williams served as 2008-10 Nu Chapter President. She held chapter offices of both First and Second Vice President as well as Motivator, History and Archives Chair. She currently serves as Co-Chair of Rules and Bylaws.

Williams retired after 38 years (2012) as Math Teacher, Department Coordinator and Senior Supervisor of Math at Shawnee High School in Medford, NJ. She also served as a mentor of the National Board for Professional Teaching Standards (NBPTS), a member of the Governor's Teacher Advisory Committee and as a member of the Math/Science Consortium of Burlington/Mercer Counties.

Williams shares her thoughts, "...declining membership has been a problem for many years now and we need to continue to work on new ideas and ways to recruit new members while retaining our existing members. This has to be a priority if we are going to keep the Society moving into the future. I have watched many incredible women fill the leadership positions since my initiation in 2003 and would be honored to continue to be part of the leadership team for Alpha Zeta State during the next biennium."



**Dr. Pamela Albert-Devine** (*Mu*) is the nominee for **AZS Second Vice President**. Albert-Devine currently serves in the position of Second Vice President. Albert-Devine served as 2013-15 AZS Corresponding Secretary. She has served as state chair for the Leadership Development, Research and Technology Committees. Under her leadership the first Alpha Zeta State website was created. She served as Mu Chapter President for six biennia. Albert-Devine is the Principal of the Point Road School in Little Silver. Prior to her current position she was Supervisor of Curriculum and Instruction for the Little Silver District.

Albert-Devine writes, "I can vividly remember my initiation in 1983 into Delta Kappa Gamma as if it were yesterday; clearly joining this organization changed my life. With each passing year my membership reminds me of the importance of recognizing outstanding women ed-

CTAUN, the Committee to Teach About the U.N., meets monthly to plan its conferences at the UN/NYC headquarters, Austin, Texas, and Atlanta, Georgia. A conference is planned for April 8, 2017 at the University of Oklahoma, in Edmonton. The theme is "Women of the World: Empowering Women, Eliminating Violence and Promoting Gender Equality."

On January 27, the CTAUN/NYC conference focused on "Refugees: the 21st Century Challenge." The morning session opened with a discussion about the issues surrounding refugees and migrants and the UN involvement with them.

The afternoon session had two parts: a panel of students, who were refugees, moderated by a former refugee and now a UN leader, and another panel of people who offered assistance and marshalled resources to aid refugees.

In addition to the panels, there were awards for posters, excellence in education, and recognition as a Global Citizen. Concurrent with the conference was the Information Fair. Here many UN agencies, as well as outside NGOs brought materials to share with the conference attendees.
